

# Transferring to Foster Wales Swansea







#### Who are we?

## Already a foster carer?

The aim of Foster Wales Swansea is to increase the number of foster carers working with us rather than independent fostering agencies. This is so we can provide the best outcomes for children. We know our in-house carers extremely well, in terms of their skills, strengths and experience. This means we can get the right match for the children and the carers too. Unfortunately when placing children with other agencies, we don't know the carers. It also ensures that any savings accrued from carers transferring over to us, can be invested in supportive services for the children and carers, including early psychological and therapeutic intervention.

We take pride in putting the children at the heart of everything we do which is why we take a holistic approach to their needs by working as a team around the child. We work side-by-side with the children's social workers.

There are unmeasurable benefits for both foster carers and the children when we place children with our own in-house carers.

This guide should provide you with the information you need about the transfer process. If you do decide to transfer to Foster Wales Swansea, we'll support you every step of the way and do all we can to make the process of joining us as simple as possible.



## Why transfer to Foster Wales Swansea?

As a not-for-profit organisation responsible for the children in our care, Foster Wales Swansea believe in working as a team with foster carers to build better futures for local children by helping them stay in their local area.

We are the real people in your area already supporting the children in need of looking after. We're not a distant, faceless corporation that doesn't understand your world. We're familiar and friendly, available, and accessible whenever and wherever you need us. We're people who understand your way of life.

It enables us to embed local networks of support and better encourage positive connections to a child's locality, including their schooling and time with birth family and friends. By providing what you need to support the child in the best way possible, means there are better futures for all involved. By working directly with us – the people responsible for the children in your care - we will be better informed to ensure you get the advice, training and support you need to do this.

### How to transfer to Foster Wales Swansea

We aim to make the transfer process as straightforward as possible when moving from your current fostering agency to us. From our initial chat we will talk openly with yourself about how the process is going to work for you.

As you are already a foster carer, the process is going to be specific to you. We will work with you right from the start to know how we can best support you going forward, identify any needs you have, and make sure we know you inside out for future matching. Each stage of the transfer process will be unique to you and will depend on who you foster for, whether you have children currently placed with you, and how long ago your original Form F assessment was completed.

We have a lot of experience of the transfer process, so are aware of the possible pitfalls and can preempt the things that might slow the process down. We have now learnt how to make this as seamless as possible and you will be kept in the loop all the way through.



## The process

Route 1 - no child currently placed with you	<ul> <li>Step 1 - Talk it over</li> <li>Talk this over with the Foster Wales Swansea team. Supporting you starts here. We will get to know why you want to transfer to us, talk through any you current local authority, and what you would like to gain from transferring over to us. We will take some details of you and arrange a home visit with one of our social workers.</li> <li>Step 2 - Decide to transfer</li> <li>Once we have met and you have made the decision to transfer, this is then when we would expect you to let your applied to foster with us and you intend to resign. It must be clear you are not resigning yet but you intend to on the completion of your assessment with us.</li> <li>Step 3 - Assessment accepted</li> <li>Once we have accepted your application, you will then meet your assessing social worker, who will be with you throughout your assessment authority.</li> <li>The regulations mean we have to carry out a new Form F for you, but if you foster for a local authority we can easily get hold of your previous Form F assessing social worker and capture your fostering experience to-date and ongoing development and support. At this stage, we will obtain a reference from the local authority.</li> <li>Step 4 - Final decision</li> <li>Once our assessment is complete, you will be able to give 28 days' notice resignation to your local authority. The assessment will be presented to our fostering panel.</li> </ul>	<ul> <li>Step 1 - Talk it over</li> <li>Talk this over with the Foster Wales Swansea team. Supporting you starts here. We will get to know why you want to transfer to us, talk through any current agency, and what you would like to gain from transferring over to us. If the Independent Fostering Agency you foster with agrees to share your Form F with us then this will really help to aid the sessions with your assessing social worker and capture your fostering experience to-date and ongoing development and support. At this stage, we will obtain a reference from your agency.</li> <li>However, where they decide that they won't send us a copy, we will have to start from the beginning. Where this is the case, we will prioritise your application and work hard to speed up the able to give 28 days' notice resignation to your agency. ### The process

<ul> <li>Route 2 - currently have a child placed with you</li> <li>Steps 1 and 2</li> <li>The first two steps are the same as Route 1. However, when the agency receives your intent to resign, they will ensure the child's independent reviewing officer knows of the intended change. They will then need to hold a meeting within 28 days, involving all the relevant parties – yourself, the placing authority, your current agency and us. ### Frequently asked questions

#### Do I have to have a formal assessment to transfer to Foster Wales Swansea?

Yes, but it should be a faster process than your first application as a new foster carer. We will need your original Form F (from your current provider) and we'll go through it with you. You'll also have the usual checks, like a health and finance check. Your application to transfer will go to our fostering panel for approval.

#### Do I need experience of fostering to transfer to Foster Wales Swansea?

If you are an approved foster carer with another local authority or fostering agency, but not yet fostered a child with them, you can still transfer to us. We value experienced foster carers who want to transfer and those already caring for our children. However, we also value those just starting out on their fostering journey and you have already been assessed and provided evidence of your ability to foster in your first Form F. We understand that the realities of fostering with an agency aren't always the same as when you first apply.

At Foster Wales Swansea we treat you like real people with individual support needs and expertise. This allows us to know what matching could work well with you and what support or learning opportunities we need to provide you with so you have the confidence to best support a child.

#### Can I transfer if I already foster a child with the Swansea local authority?

You can, yes. We would actively encourage this. Your child is already being supported by their social worker who is employed by Swansea Council and part of the same department as Foster Wales Swansea. As their foster carer you are the key role in the team around your child and to have you working in-house with the rest of the team, in our experience, only improves the outcomes for children.

#### Can I transfer if I already foster a child with another local authority?

Yes, you can. The main priority during a transfer is the welfare of the child. We will need to meet with you, the child's social worker and IRO, and your current local authority to discuss the on-going care plan for the child. This meeting will explore any potential impact and if it's in the child's best interests to remain in your care as you move to another local authority. We like to keep an open dialogue with yourselves and your current local authority, so it would be good to discuss your move with them too.

#### How long will it take to transfer to another foster agency?

We appreciate that you are already approved to foster and won't want the process to be lengthy so we make every effort to approve your foster carer transfer as quickly as possible. The transfer application process is faster and simpler than if you were new to fostering, and we aim to have you approved within a much short time scale than a new to fostering Form F assessment.

## Talk to us about joining the Foster Wales Swansea team!

If you're considering a move to Foster Wales Swansea please come talk to us, this initial conversation is strictly between you and us.

We are moving more and more foster carers in-house, so can understand your reasons for considering the move and how best we support you through the transfer process.
